## Massac County Drug Awareness Coalition Annual Meeting Wednesday, August 19, 2020, 8:00 a.m. via Zoom

- 1. Welcome, Introductions, Treasurer's Report
  - a. Treasurer's Report Balance on July 31, 2020, was \$32,361.51. Expenditures were rent, supplies, payroll, marijuana training, CADCA training. Income was a donation from Powers United Methodist Church. Thank you for your donation!
- 2. Mission Statement Holly read the mission statement.
- 3. Executive Committee Holly introduced the current Executive Committee. Sabrina Beck stepped down in February and Holly thanked her for her years of service to MCDAC. Morgan Holt joined the committee in April. Steve Johnson and Rickey Griffey were both nominated to serve another 3 year term as their terms were expiring. Holly noted the members present who had been at 2 meetings this year and were eligible to vote. Holly asked for any other nominations and none were made. A motion was made by Harry and seconded by Thelma for Steve and Rickey to serve a 3 year term. A majority of voting members present voted in favor and the motion passed.
- 4. Annual Report Holly went over the 2019-2020 Annual Report. Members were thanked for their contributions.
- 5. Goals Holly read the goals for 2020-21 which are listed in the Annual Report. She advised that these were the goals listed in the DFC grant. Briefly, they are to recruit 5 new members, train members in the Strategic Prevention Framework, reduce past 30-day youth alcohol and marijuana use in 8th, 10th, and 12th graders by 10% each combined, and reduce 10th and 12th grade reports of obtaining alcohol with permission from parents by 5% combined. Holly also noted that we did not have to focus each and every strategy on alcohol or marijuana because any efforts toward reducing drug use is eventually going to affect youth use.

6. Sector Representatives - Holly listed the current sector representatives. She thanked Areia Hathcock and Cindy Davis for their service as sector reps as both resigned this year. Areia left the Metropolis Planet after the Metropolis office closed and Cindy retired from Southern Seven Health Department. Holly advised we are looking for a new media sector rep. We also welcomed Clarissa Shepherd as the healthcare sector rep.

## 7. Other -

- a. Volunteers are still needed for the Community Assessment committee and they will meet soon.
- b. Chief Masse advised that the Metropolis Police Department has a new drug dog, Krypto, and his handling officer is Nick Holland. They start patrol on August 21. They still need to raise around \$2000 to finish paying for Krypto and his care.
- c. August 31 is International Overdose Awareness Day. Clarissa advised the health department is leading an effort to bring awareness and the City of Metropolis signed a proclamation declaring the day in Metropolis. We are asked to wear purple, silver, or light gray on this day. We also have social media posts to share.
- d. Clarissa also advised that September is Recovery month. We talked about possibly doing some videos of those who have recovered.
- e. Cami said that she was supposed to go to the 6th grade classrooms in the county and talk about P2D2 with Dep. Summer Clapp before the pandemic hit. They never got to do it. She said she hopes they will be able to soon. Holly said that we could possibly provide some SWAG or brochures to help.
