# 2016-2017 ANNUAL MEETING

Our 2016-2017 Annual Meeting was held August 22, 2017, 6:30 p.m. at Metropolis City Hall, with a total attendance of 25. Accomplishments were shared and needs were discussed. Also, goals for the future included a Town Hall with Dr. Pat Withrow, Narcan Training, Truth or Consequences Event for 8th graders, a Speaker to address bullying, drug use, etc., a Trivia fundraiser, along with our established programs/projects.

A presentation regarding law enforcement efforts was given by Patrick Windhorst (on behalf of Rickey Griffey). The presentation included the following: how alcohol, prescription drug abuse & illegal drug use leads to other crimes; rather than meth labs, now we are seeing meth imported to our area; supply chain is hard to break, but if we can interrupt the demand, we can impact the problem; we won't be able to prosecute our way out of this problem; we now have an officer on the Southern Illinois Drug Task Force; we need federal prosecution to increase the charges related to drugs; opioids are not as bad as other places yet; problem is more Rx related than heroin; we are seeing an increase in IV drug use, and the jail is currently over capacity by 10.

Our Guest Speaker, Matt Lacefield (a Centerpoint employee, as well as, graduate of their rehab program and clean for 3 years), gave a moving testimony of how drug use affected his life; its beginning in his youth, continuation through the teen years and finally in his 20s when he attended rehab successfully. He discussed impact of his family life including parents and siblings, as well as his peers and friends and the influence they all had over his drug use.

Public comments included the need for more volunteers, more ideas were discussed, as was the IYS results showing the real risk between 8th and 9th grade alcohol and drug use.

# **Drug Take Back**

October 28, 2017 - For the second year in a row MCDAC assisted the Sheriff's Dept. with their Drug Take Back event. These events coincide with the National Drug Take Back days. Volunteers assisted from 10:00 am to 2:00 pm where the drug disposal box was placed on the sidewalk to ease drop-offs by the public.

### April 28, 2018 - Introducing "Points Drop"

The spring Drug Take Back event was supported by a new Points Drop program. From discussion of a community need, and the efforts of Southern Illinois Enforcement Group, Massac Memorial Hospital, MCDAC, and the sheriff's department, the Points Drop box has been made available for acceptance of used needles – no questions asked. At this drug take back day, 47.5 pounds were collected. Thank you to Massac Memorial Hospital for providing the boxes for Points Drop and the services to pick up the sharps, as well as, the ingenuity of the maintenance department in adapting the container so the sharps drop into the container safely and efficiently. Thank you to our volunteers who help, Massac County Mental Health for being on hand with information, and to Southern Illinois Enforcement Group.

# **Town Hall Meeting**

November 7, 2017 - Johnathan Oberholtz of SIEG began the meeting with a presentation of alcohol/drug use statistics from the Illinois Youth Survey results from Massac County. Dr. Withrow, Baptist Health Paducah outreach coordinator and retired physician presented information on addiction and how the brain can get "hijacked" from the first use of drugs. A question and answer session followed. Narcan training was presented by Egyptian Health Department with free Narcan kits made available upon completion of training. In attendance were over 80 citizens representing many sectors of the community. Information tables were made available by MCDAC and Massac County Mental Health.

# Truth and Consequences @ MJHS 8<sup>th</sup> graders: Holly Windhorst

May 14, 2018 - This event was held at Massac Jr. High School and included many sectors of the community from law enforcement, hospital, probation, funeral home, judge, pharmacists, and clergy. Parents were asked to attend alongside their child to go through different scenarios which showed the consequences of various choices that may have lead to injury, arrest, or even death of self or a friend. We are grateful for the many professional volunteers whose engaging participation made an impact on many of the students. Also, thank you to the "parent" volunteers and the parents who were able to attend with their student. Thank you to Legence Bank for the donation of food for our volunteers.

MASSAC COUNTY HIGH SCHOOL: 25 student members participated this year. A "Hat Day" was held in October 2017 and \$50 was raised. In May 2018, the students supported MCDAC's presentation of the Truth and Consequences program to 8th grade students at Massac Jr. High. In July 2018, two YAC students attended CGTI (Cebrin Goodman Teen Institute). They both participated in PALS (Peer Advanced leadership Skills) as part of staff in training for CGTI; they would like to serve as staff members next year. \$50 gas card was provided for transportation. 


